These lesson plans include course outcomes, course objectives, content topics, reference books, and the expected outcomes from the students by learning through the topics prepared by respective faculty members at the beginning of the session. Lesson plans are like headlights under which we focus our plans to cover the curriculum. Orientation Programme- is also organized for newly admitted students to make them aware of the mechanism for curriculum delivery and implementation 5. Class Test / Surprise test and student seminars are held after completion of a section of the syllabus and

periodic reviews of the performance of students are undertaken. 6. Tutorial classes are also held for weaker students so that each and every student equally contributes to the up-gradation of society. 7. Postgraduate students are specially trained to handle assignments and dissertations to prepare themselves for academic research in the future. 8. Interactive sessions are held between students and teachers to clarify their problems regarding the various topics undertaken according to the syllabus.
